### History

The Police Association of Virginia was started in 1941 as the Norfolk Police Division Alumni Association. In 1943 members of the Portsmouth Police Relief Association were voted into membership, and in 1947 patrolmen in the Norfolk and Portsmouth Police Departments were admitted into the organization for the first time. In 1948 the name was changed to the Police Association of Virginia. The Association has grown from the original 33 members of 1941 to over 500 members today.

### Purpose

To uphold and maintain the Constitutions of the United States of America and the Commonwealth of Virginia. To promote cooperation and a more binding Association between Police Departments throughout the Commonwealth and, where possible, affiliate with all law enforcement agencies, in a fraternal manner. To maintain a trust fund, to which each member shall contribute, and to provide to the beneficiary of a deceased member a pecuniary amount in accordance with the provisions of the by-laws.

- \* The annual membership dues are only **\$10.00** per year.

### Membership Requirements

Any active or retired Local, State, or Federal members of law enforcement agencies in the Commonwealth of Virginia, who were by law given the power to make legal arrests.

Applicants must not have reached **fourty-seven (47)** years of age by the time of acceptance by a majority vote by the members present at a General Body Meeting.

Applicants must be in good health at the time of application.

### Death Assessments and Dues

Applicants must submit (1) \$4.00 death assessment fee and a \$10.00 yearly dues fee with a completed application (Total \$14.00).

*Upon the death of each member, a death assessment fee of \$4.00 shall be made against each member of the Association.*

### Meetings

The Police Association of Virginia holds (4) **FREE** luncheon meetings per year (January, April, July and October) in the Hampton Roads area.

In addition to the quarterly meetings, the Association also sponsors an Annual Ladies Night Dinner Dance held in November of each year **FREE** to its members and spouses.
